## WAIVER FOR USE OF SCHOOL FACILITIES BY INDIVIDUAL

This form is intended for use when a party desires to use facilities on our property and is not a member of an organized group, and thus would not be able to obtain a certificate of insurance from the policy of a sponsoring organization.

We expect this form will be used sparingly. Most groups are part of an organization that will provide us the required certificate. As examples, we already have blanket forms covering all our facilities for all activities from the town of Normal, City of Bloomington, the Girls Scouts, and the YMCA.

An example of when to use this form would be for use of our gyms for practices by a team run through Game-Time gym. Game-Time does not feel practices are a necessary part of their program, and will not provide coverage for participants in their program for activities away from their facility. Another example of appropriate use of this form would be in the case of a group who get together to play a sport in or on our facilities without participating in any organized league.

It is important to note that if we do not have a certificate of insurance, **every** participant using the facility must complete this waiver. It is not sufficient for the person completing the facility usage agreement to complete the waiver for the entire group. Should it be determined that someone is participating in an activity at the facility without either a certificate of insurance or an executed waiver agreement, the group will not have further access to the facility until we are supplied the missing document.

Is a homeowner's policy sufficient insurance? No. We could accept a certificate issued on an individual's umbrella liability policy if it named us as an additional insured, but a homeowner's policy, by itself, doesn't have the correct coverage. Also, we have been contacted by some agents to discuss this at the request of their insured. In those discussions, we have been informed that certain carriers do not provide this type of certificate at all.

Please keep a copy of these waivers at your building. The originals, along with the original of the usage agreement should be sent to the Unit office.
