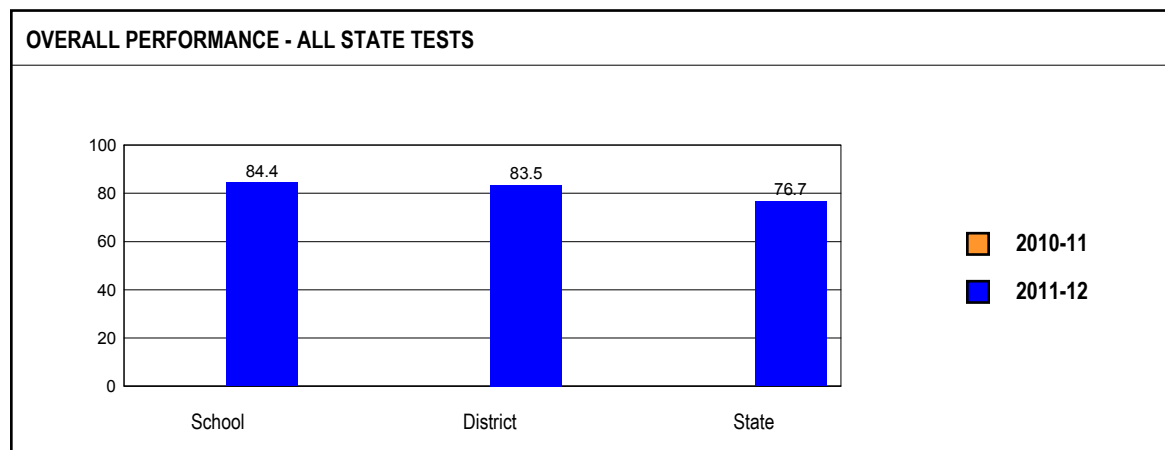

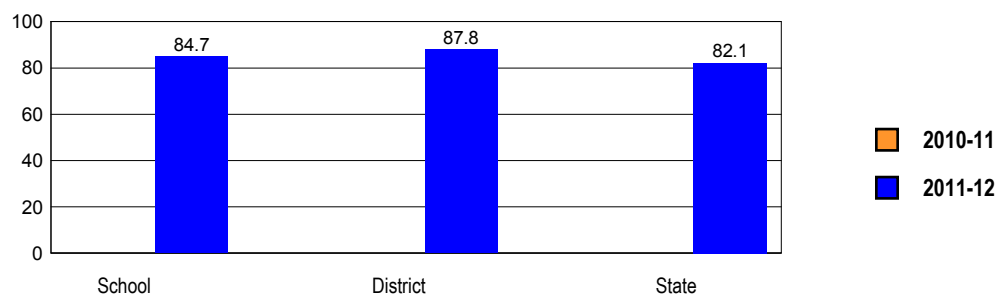

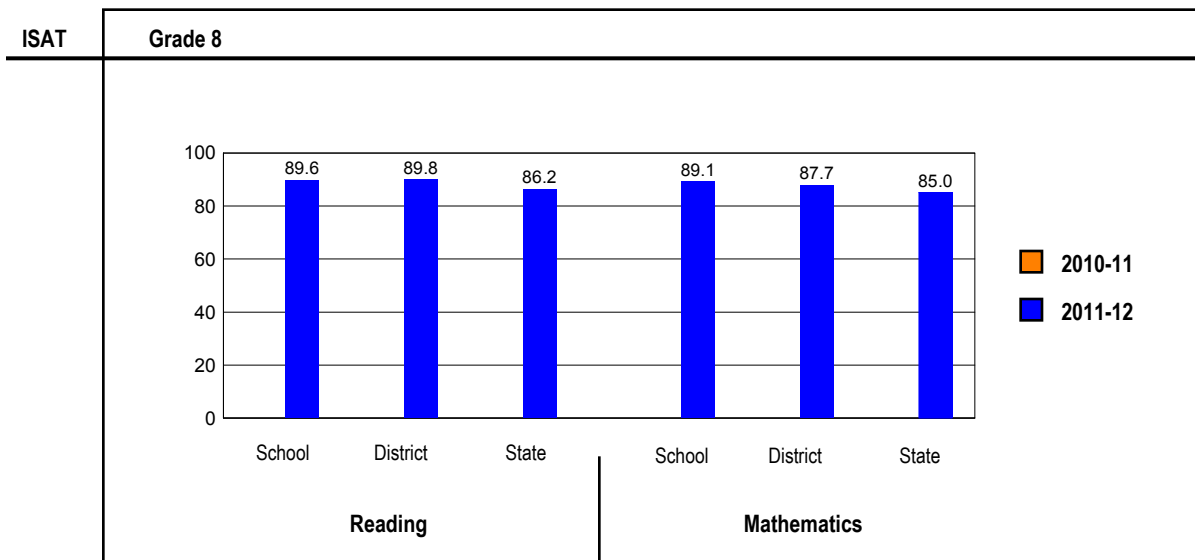
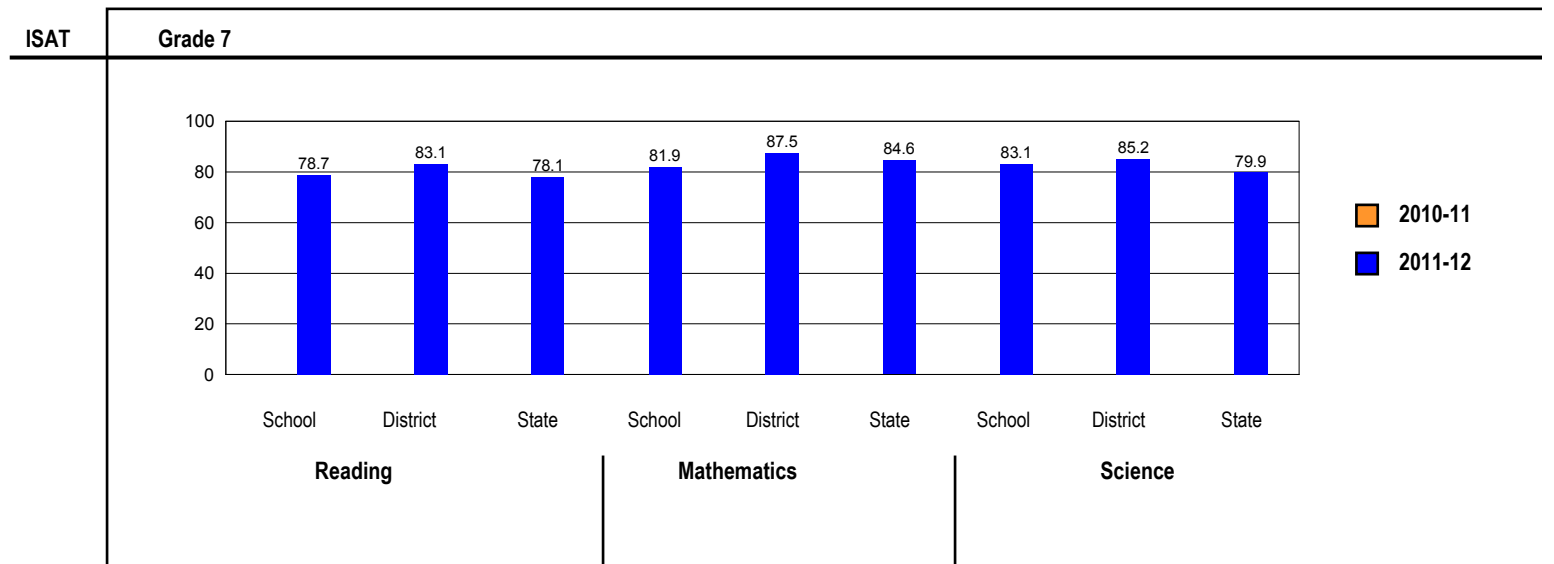
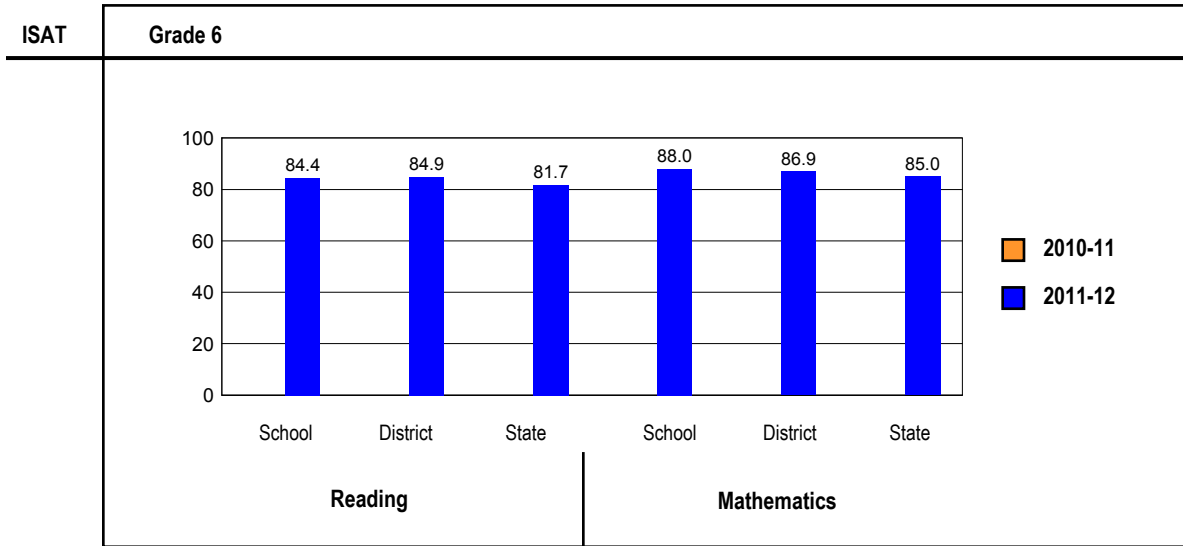


**OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE**



**ISAT PERFORMANCE**

## PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

### ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

- Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.
- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.
- Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

The EJHS staff will continue to train on the Comprehension Focus group intervention and implement this intervention with students performing below grade level. Continue to utilize literacy coach to meet with academic teams to develop and implement instruction and interventions to support students on team. Staff will fully implement the reader's workshop model in all literature and composition classes. Training will be conducted on Collaborative Reasoning as well. Guided reading plus will be utilized as an intervention for students performing below grade level. School wide literacy initiatives such as Article of the Week will be an expectation for classroom teachers to implement.

Literacy team and CORE team will work to establish and promote literacy activities to be taught/presented in tutorial.

The literacy team will develop a building based vocabulary program such as Word of the Week to provide exposure to all students to multi-syllabic words.

School wide literacy initiatives that include a focus on the cycles of implementation, identified comprehension strategies and focus, school wide book drives, implementation and continued training on the workshop model as well as the comprehension focus group intervention.

All teachers will work with technology to utilize a variety of media for students to read and analyze.

Professional learning community and grade level focus on the development of common rubrics to assess strategy acquisition for each student. Determination of assessment passages and criteria to show mastery of specific reading strategy.
