Enrollment Update

Cunningham reported on monthly enrollment figures. (Attachment #8) Total enrollment as of December 20, 2011 was 13,288.

Actual Enrollment 1996-2011 and Projected Enrollment 2012-2020

Niehaus provided an update on enrollment trends and projections through 2020. (Attachment #9) Niehaus reported that administration continues to watch growth on the east side of the District specifically Benjamin Elementary School attendance areas. Niehaus reported that high school enrollment is also a concern noting that in 2014 growth will be 3.4 percent and by the year 2015 both high schools will be over capacity. Administration will continue to monitor growth to determine the need for possible redistricting as well as additional schools.

Wellness Report

Dayna Brown and Susy Marcum reported on the Wellness Committee's goals for 2011-2012. (Attachment #10) It was reported that Unit 5 is far ahead of national statistics on adopting the USDA National School Lunch Program's recommended changes to District initiatives and programs. The committee continues to engage parents, students, and staff and hopes to exceed the number of wellness teams in Unit 5. In accordance with Board policy, the committee is asking each school to offer more nutritious foods throughout the school day including in the lunchroom, vending machines, fundraisers and concession stands. Brown also reported that one of the Citizens Advisory Council's study topics is on the topic of wellness and nutrition.
