## Debt Review and Series 2008 Refunding Opportunity

Scott Smith of PMA Securities, Inc. and Todd Krzyskowski of Mesirow Financial provided information on the Series 2008 bonds and refunding opportunities available to the District. (Attachment #7) Discussion included but was not limited to the following:

- Investments in Illinois GO Bonds
- Risks including interest rates and State of Illinois GO Bonds liquidity
- Refunded bonds and new refunding bonds both count against the District's debt limit
- Credit rating scales and definitions
- Debt profile and legal debt margin

It was the consensus of the Board to have the Strategic Planning and Finance Committee continue discussion on this matter with administration and representatives from PMA Securities, Inc.
