Reports

PBIS

PBIS program representatives reported on the Positive Behavior Interventions and Support programs in Unit 5. (Attachment #4) Representatives include: Unit 5 PBIS coordinator Nancy Braun; Cedar Ridge Elementary School principal Geoff Schoonover and teacher Karl Goeke; Oakdale Elementary School principal Darrin Cooper and teacher Kathy Fitzgerald; and PJHS associate principal Mike Clark and teacher Deb Brown. Discussion included the Illinois PBIS Network, Response to Intervention, individual school's PBIS program implementation and practices to promote positive classroom and social culture, internal and external coaches, and staff training through the Professional Development Academy.

Quarterly Budget Update

Bush presented the first quarter budget report. (Attachment #5) He noted that the budget is tracking in a positive direction; however, the State still owes the District \$1.7 million to the Education Fund and \$1.07 million to the Transportation Fund. Discussion also included the increase of staff including seven teachers and 12 additional paraprofessionals, growing enrollment, the reduction of over \$1 million in other revenue sources, and the decline in property tax base value.

Enrollment Update

Cunningham reported on enrollment figures. (Attachment #6) Current enrollment is 13,264.

1st Reading Board Policies, Administrative Procedures, and Exhibits

Briggs presented the following policies, administrative procedures, and exhibits for 1st reading. These will be scheduled for 2nd reading and adoption at the December 14 regular meeting. Board members were asked to provide feedback to Briggs prior to Thanksgiving break. - Board Policy Review Committee ~ The next policy meeting is scheduled for Monday, December
- Facilities Review Committee ~ The committee met on Friday, October 28. Discussion included
 life safety needs. The November 11 meeting has been cancelled. Niehaus reported that he has had
 discussion with committee members regarding performance based contracting. It was noted that
 Adelman will provide a construction report to Board Members. The report was presented to the
 committee previously and included information on completed construction projects and plans for
 future needs.
- McLean County Regional Planning Commission ~ The commission met on Wednesday, November 2. Reece reported that Heartland Community College will be adding a military readiness center. Reece noted that there has been some concern about possible issues with traffic in the area and equipment storage for contractors. Reece reported that Niehaus will speak at the next meeting of the commission on Wednesday, December 7.
- Beyond the Books Educational Foundation Board of Directors ~ The next meeting is scheduled for Thursday, November 10. The agenda will include a presentation from April Schermann and a brief update on the Beyond the Box grant recipient Kevin Enderlin. Briggs reported that the foundation is looking at a change in scheduling that is being proposed by the grants committee for the process of grant application, completion, and deadlines for both the Beyond the Books regular and Beyond the Box grant cycles.
- Illinois Association of School Boards ~ The IASB/IASA/IASBO joint annual conference will be held in Chicago November 18 20. Briggs noted two resolutions that were not recommended for adoption at the conference this year will be considered for presentation if the majority of the assembly members agree to hear the appeal. One is a resolution regarding the Association's position statement on consolidation and unit districts. The other resolution is asking for consideration of allowing school board members to be paid.
- Unit 5 Foundation ~ The next meeting is scheduled for Wednesday, November 30.
