District procedures. Niehaus reported that District administration will continue to meet with the American
Federation of State, County, and Municipal Employees Council 31 (AFSCME) representatives regarding
contract negotiations for transportation department employees. Discussion also included employee
absenteeism, turnovers, and recruitment. Trask moved, Pritchett seconded, to adopt the Resolution of the
Board of Education of Community Unit School District No. 5, McLean and Woodford Counties, Illinois,
authorizing and directing the Superintendent to solicit bids for transportation services as presented. Roll
